## San Jose Bicycle Club (SJBC) Code of CONDUCT

SJBC members must be conscious of their role as ambassadors to the non-cycling and recreational cycling communities. The SJBC name and logo, such as on apparel, is an advertising vehicle for the club.

Our guiding principles:

- Abide by all relevant traffic regulations whether on individual or group rides; respecting rules of the road and maintaining safe riding habits. Failure to abide by bicycling traffic laws, if observed by the public can be extremely detrimental to the club's image.
- 2. Assist any rider having mechanical or physical difficulties on SJBC rides when they are unable to continue to ride safely.
- 3. Speak and act with the intentions of including others
- 4. Honor language an individual chooses for themselves
- 5. Not make assumptions about gender, race, ability, skill level, or knowledge 6. Listen when something I do or say is hurtful
- 7. Respect the Indigenous stewardship of the land we ride on
- 8. Make intentional space in cycling for Black, Indigenous, people of color, and trans people

As an SJBC member I promise to practice good sportsmanship and conduct myself in a respectable manner at all cycling and non-cycling events where I am representing SJBC. ("Representing the club" is considered to be anytime you are at an event where you are registered or volunteering as an SJBC member, and/or anytime you are wearing apparel that includes the name and/or logo of SJBC, including but not limited to, social media and other technology/networking platforms.)

Inappropriate and unacceptable behavior includes but is not limited to:

- 1. Physical or verbal abuse to any person/group or property while riding or at any club event, including use of foul language, or making obscene gestures towards any person.
- 2. Malicious actions at an SJBC event that endangers the well-being of others. 3. Unlawful activity, including theft or fraud, intentional damage to property; and use, sale, possession, or distribution of illegal drugs.
- 4. Non-consensual physical contact of people or bikes, threatening or bullying behavior, unwanted sexual advances, and any other inappropriate behavior. 5. Conduct or speech (verbal, written, or online) which is hostile, abusive, shaming, harassing, or discriminatory toward others. This includes, but is not limited to, conduct in relation to age, disability, socioeconomic status, education, national origin, marital status, pregnancy, religion, race, ethnicity, sexual orientation, or gender identity.

- 6. Other inappropriate conduct that reflects poorly on SJBC and/or upon cycling in general.
- 7. Repeated failure to honor commitments undertaken as an SJBC member. 8. Failure of any member to report inappropriate activity or unacceptable activity as noted in the following:

Members who experience or witness inappropriate or unacceptable activity as outlined above are expected to promptly report the issue to a club officer (President, Vice-president, Secretary, or Treasurer). The activity will be investigated and appropriate action or inaction will be taken. To facilitate a prompt investigation, we urge that such reports be in writing with a description of the incident(s), names of the individuals involved, names of witnesses; and relevant dates, times, and locations. Disciplinary actions may result in the revocation of all membership perks and/or privileges. All members demonstrating a manifest unwillingness to meet this Code of Conduct will be subject to suspension of club privileges or their club membership.

SJBC Membership is a privilege. Membership may be revoked, suspended, or denied; if after due consideration, an assembled quorum of the Board determines by supermajority vote, that a member is in material violation of this Code of Conduct.

If I am a USA Cycling member and/or license holder (including all SJBC Race Team members), I will also abide by the the USA Cycling Code of Conduct (<a href="https://www.usacycling.org/about-us/governance/code-conduct">https://www.usacycling.org/about-us/governance/code-conduct</a>) and the Athlete Protection Policies (<a href="https://legacy.usacycling.org/athlete-protection-policies.htm">https://legacy.usacycling.org/athlete-protection-policies.htm</a>). Any violation of these policies could result in a USAC investigation and/or suspension or removal of the member from the club.
